Upon signing this contract, it is legally binding and both the Makeup Artist and said Client agrees as follows:

1. Makeup Artist's obligation to provide services hereunder is subject to change because of serious illness, acts of God and other reasons beyond the Makeup Artist's Control. In this event the client will receive a full refund.
2. Client agrees to notify Makeup Artist of any **allergies** he/she may have toward any cosmetic products and chemicals. Should a reaction occur, requiring medical attention or not, it is agreed that the Makeup Artist is not legally liable or responsible for injury and/or ailment of any kind.
3. **CANCELLATIONS:** In the event the client needs to cancel service, the **client will lose the deposit made to the Artist**. Cancellation can be made no later than **2 weeks** prior to the service date or else they will be subject to an additional \$50 cancellation fee.
4. **PAYMENTS:**
  - A **50% non- refundable deposit** is required to hold the date and the remaining balance is due on or before the wedding day.
  - Only cash, personal check or debit/ credit card transactions are acceptable forms of payment. In the event a check is returned for non-sufficient funds, the bride will be responsible for the original payment as well as all check fees. **Make checks payable to Paris Draper**
  - **Hourly Rate:** \$50 per hour (pertains to client if needed for pictures/ touchups during or after wedding)
  - **Travel Rate:** ½ of hourly rate- \$25 per hour of travel from location of the Artist.
  - The client will also pay any necessary valet parking, hotel accommodations and flights.

For an additional fee of **\$60** each, the Makeup Artist will provide makeup services for the following members of the party: \_\_\_\_\_
